NOTE REGARDING COOPERATIVE EDUCATIONAL AGREEMENTS: *Rock Valley College has career education cooperative educational agreements with several Illinois community colleges so that students may enroll in **occupational degree and/or certificates programs not available at RVC.** Prerequisite course requirements may be taken at the home institution or at the receiving institution. The cooperating college will issue all degree or certificates for successful completion of the individual program. **The student pays the in-district tuition of the offering institution.***

A variable tuition rate of \$139.00 per credit hour, in addition to the standard tuition rate, will be applied to all nursing courses in the AND/LPN program and all courses in the Radiologic Technology program.

*** Costs information regarding additional tuition costs** for AET/MT, AMT. CAD. CRT. DPT, ELE, EMS, EST, TPM, and WT programs:

A variable tuition rate of \$69.50 per credit hour, in addition to the standard tuition rate, will be applied to all first year courses in these program effective Summer, 2017.

COST for Tractor-Trailer Driver Training and other Information on the Training:

Requirements: 21 years old to receive CDL license; hold current Illinois driver's license; able to read English at not less than 7th grade level; and have passed a DOT physical and drug screening; have good driving

Information on Training: Day classes are held from 8 a.m.-4:30 p.m. The class can be completed in 4 weeks. Night classes are held 5:00 p.m. to 9:30 p.m. Monday through Thursday. The class can be completed in 9 weeks. Classes may take longer depending on the student, holidays, and other factors. Classroom training is in Room A-220 in the Kishwaukee College Conference center. The remainder of the class time is spent in yard and road training (extensive).

Kishwaukee College - Refund Policy 2017

A 100% refund will be granted for classes dropped within the first 6% of the course, as measured using the start and end dates of each course. A 50% refund will be granted for classes dropped after 6% of the course has expired but within the first 12% of the course. (Check the FA17 Refund-Withdrawal Date information for more specific class dates. The amount of refund is calculated from the date the class is dropped. The exact drop dates for each course can be found on the student schedule bill and online. Refunds will be made only after a student drops a course, either in person or online.

Refund credit can be applied to the cost of other courses during the same semester. Otherwise, a refund will be mailed or credited to a credit card within 45 days from the date of withdrawal from the class. A full refund will be granted for courses canceled by the College. Refunds are not granted if a student has been withdrawn due to misconduct or delinquent attendance.

This policy does not apply to Continuing Education classes. If Financial Aid was used to pay tuition and fees, the refund will be applied to the financial aid programs that paid the charges. The Higher Education Amendments of 1998 have mandated additional requirements concerning refunds of tuition and fees to Title IV Financial Aid programs for students who drop or withdraw from courses for which Title IV funds were used. If students withdraw from all courses before 60% of the term has elapsed, they may owe a portion of the financial aid previously disbursed. For further information on this refund law, contact the Financial Aid office.

REFUNDS FOR NONCREDIT CLASSES

No refunds are issued after the first class session unless otherwise specified in the class listing. A full refund will be granted for classes cancelled by Kishwaukee College.
